5. Christmas Tree Lighting 2017

Following discussion regarding annual tree lighting ceremony and the location for the Christmas tree, it was suggested that the possibility of it being placed at the Kalisgarth Garden should be considered. Members were also advised that Westray Development Trust (WDT) had agreed to provide funding up to £970, and it was:

Resolved:

- B. To send the Clerk a list of what was planned and booked for the Tree Lighting.
- C. To note that funding of £970 had been granted by WDT.
- D. That members would ask for local views on the preferred location for the community Christmas tree.

It was also raised that previously, inlets had been cut to allow these areas to drain into the ditches, which it would appear no longer happened. Members asked if clarification could be sought on the procedure for having water runs placed in the verges, and it was:
